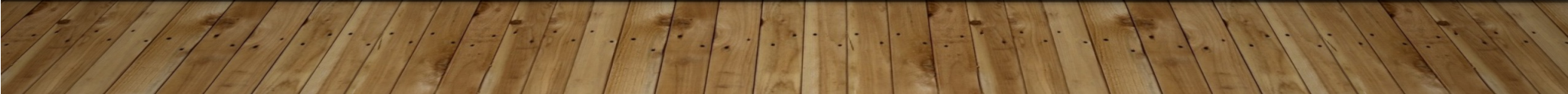
It is our pleasure to host some of the best experts in their field and provide the latest information as you continue your educational journey.

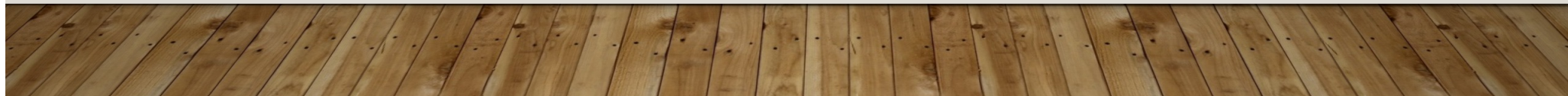

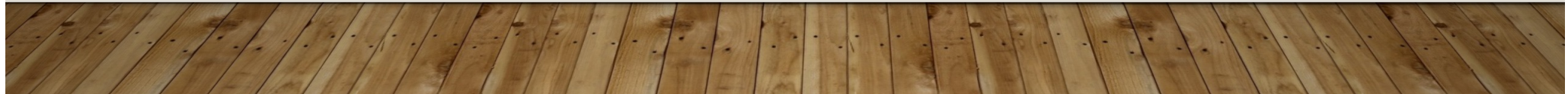
